Chairman Yancey introduced Ms. Lori Durden, President of Ogeechee Technical College.

Chairman Yancey called on Captain Mike Burgamy for the invocation.

Chairman Yancey adjourned the Board meeting to move into the Committee meetings.

Chairman Yancey called the meeting of the Board of Natural Resources to order.

Chairman Yancey called for a motion to approve the minutes from the Board of Natural Resources meeting on October 26, 2021.

Chairman Yancey called for a motion to approve the minutes from the Nominating Committee meeting on November 22, 2021.

Chairman Yancey called on Richard Dunn, Director of the Environmental Protection Division, for his report.

Director Dunn updated the Board on new water and sewer infrastructure projects in partnership with the Governor's office, and new developments regarding the Golden Ray salvage project, continued assessment and monitoring, and a proposed agreement with the responsible party.

Director Dunn stated this concluded his report.

Chairman Yancey called on Mark Williams, Commissioner of the Department of Natural Resources, for his report.

Commissioner Williams recognized Director Rick Dunn for 20 years of service to the State of Georgia and presented to him a Faithful Service Award and 20-year service pin. Commissioner

Williams stated that Director Dunn is a valuable member of the DNR family and has been a consummate public servant. He congratulated him and thanked him for his dedication and service.

Commissioner Williams provided an update on the 2021 Leadership Academy; the DNR Career Academy; and the 2022 Weekend for Wildlife.

Commissioner Williams called on Colonel Thomas Barnard, Director of the Law Enforcement Division, for his update.

Colonel Barnard provided an update on the Division's highlights from around the state; Atlanta Crime Suppression Detail; the Army PaYS Signing Ceremony; and Thanksgiving week activity.

Commissioner Williams called on Jeff Cown, Director of the Stated Parks and Historic Sites Division, for his update.

Director Cown provided an update on the 2021 Association of Southeastern State Park Directors Conference at Brasstown Valley Resort; George T. Bagby State Park's transition from Coral Hospitality on November 1; National FootGolf Championship at Brazell's Creek at Jack Hill State Park; Indian Springs Workday on November 9; Fort Yargo Workday on November 18; Magnolia Springs Workday on November 18; and Fire Training at Plains Welcome Center.

Commissioner Williams called on Doug Haymans, Director of the Coastal Resources Division, for his update.

Director Haymans provided an update on Marine Fisheries; Habitat News; Research Vessel Glynn; and the removal of the Golden Ray.

Commissioner Williams called on Ted Will, Director of the Wildlife Resources Division, for his update.

Director Will provided an update on the Wildlife Conservation staff's work to save endangered North Atlantic right whales and to raise awareness and reduce the risk of vessel strikes by charter boats and boats under 65 feet; debut of the ActionTrack Wheelchairs at state properties across Georgia; opening of Two Rivers Gun Range on November 12; Construction and sanitation at Buford Hatchery; Delayed Harvest Streams Stocked; and Next Year Class of Trout Underway at Burton and Summerville Hatcheries.

Commissioner Williams stated this concluded his report.

Chairman Yancey called on Miki Thomaston, Chair of the Coastal Committee, for her report.
