Chairman Jones called on Cathy Barnette for a declaration of quorum.

Chairman Jones adjourned the Board meeting to move into the Committee meetings.

Chairman Jones called the meeting of the Board of Natural Resources to order.

Chairman Jones called for a motion to approve the minutes from the Board of Natural Resources meeting on January 28, 2022.

<u>A motion was made by Mr. Sinyard, seconded by Mr. Johnson, and carried unanimously</u> to approve the minutes from the Board of Natural Resources meeting on January 28, 2022.

Chairman Jones called on John Eunice, Deputy Director of the Environmental Protection Division, in the absence of Director Rick Dunn, for his report.

Deputy Director Eunice updated the Board on funding from the Governor for water and sewer infrastructure, the new Chief of the Watershed Protection Branch, HB 893 and other legislation pertaining to EPD operations, and the FY 2023 budget for EPD.

Deputy Director Eunice stated this concluded his report.

Chairman Jones called on Mark Williams, Commissioner of the Department of Natural Resources, for his report.

Commissioner Williams began his report by thanking everyone for their support in the 2022 Weekend for Wildlife. He stated that \$2,057,000 was raised, and he thanked GNRF Director Lyndy Saparow and Lacey Creech and her team at the Wildlife Resources Division for a fantastic event.

Colonel Barnard provided an update on Inservice Training; 36th Game Warden Academy; Jekyll Creek Homicide Assist; Recent Aviation Missions, Atlanta Crime Suppression; and Sinclair Boating Incident.

Commissioner Williams called on Jeff Cown, Director of the State Parks & Historic Sites Division, for his report.

Director Cown provided an overview of the Unicoi Wildfire, including incident command and operations; Super Museum Sunday; Parks on the Air at Cloudland Canyon; Little White House Exhibit; Magnolia Springs Partnership; and Prescribed Fires in February.

Commissioner Williams called on Doug Haymans, Director of the Coastal Resources Division, for his report.

Director Haymans provided an update on the Redfish Symposium at the GAAFS 2022 Annual Meeting; Offshore Reefs; and the Georgia Healthy Beaches Program.

Commissioner Williams called on Ted Will, Director of the Wildlife Resources Division, for his report.

Director Will provided an update on the 2021-2022 prescribed burn season; fish habitat enhancement; renovation of the Steve Cocke State Fish Hatchery in Dawson; warmwater hatcheries stocking intermediate sized channel catfish in lakes; and surveys of bald eagle nesting and shorebirds.
