Jeff Cown, Director James Boylan Chuck Mueller Anna Truszczynski Katie Hegarty The February 27, 2024 meeting of the Coastal Resources Committee was called to order by Joe Hatfield, Chairman of the Board of Natural Resources.

Chairman Hatfield called on Nancy Addison, Chair of the Coastal Resources Committee. Ms. Addison called on Jill Andrews, Chief of Coastal Management Section, Coastal Resources Division, to present the proposed amendments to the Rules of the Department of Natural Resources Coastal Resources Division, Regulation of Upland Component of a Project, Chapter 391-2-3-.02.

Ms. Andrews stated the Upland Component is a service area, amenity or recreational area that augments the functioning of a CMPA permitted project, or those facilities intended to exclusively serve the users of the CMPA project, such as dry stack storage, dockmaster shop, restrooms, fuel storage, delivery facilities, and other facilities determined by the Coastal Marshlands Protection Committee as likely to alter coastal marshlands. She further

Ms. Andrews stated that the purpose of the proposed amendment is to clarify the Rule is to apply only to marinas, community and commercial docks, fishing piers, boat ramps and bridges. She added there were a total of 163 comments received during the public comment period and included stakeholder engagement/public involvement, suggested amendments for proposed changes, requiring buffers on hardened shorelines and incentivize living shorelines, procedural concerns with rulemaking process, and coordination with EPD regarding buffers.

Ms. Addison stated there are two speakers signed up for comment. She called on Mr. Bill Sapp, Senior Attorney, Southern Environmental Law Center, who spoke in opposition to the proposed amendments.

Ms. Addison called on Ms. Alice Keyes, Vice President of Coastal Conservations, One Hundred Miles. Ms. Keyes spoke in opposition to the proposed amendments.

Discussion ensued.

Ms. Addison thanked Mr. Sapp and Ms. Keyes for their time and comments.

A motion was made by Ms. Addison, seconded by Mr. Denney, and carried unanimously that the Board adopt the resolution to approve the proposed amendments to the Rules of the Department of Natural Resources Coastal Resources Division, Regulation of Upland Component of a Project, Chapter 391-2-3-.02.

There being no further business, the meeting was adjourned.
